


Oscar Addison being first duly sworn, on oath sayeth, I am a Civil Engineer. That during the month of March 1883, I executed a survey of the blocks, lots, streets and alleys represented by this map, and called Railroad Addition to the Town of Missoula. That said addition was surveyed and laid out according to this map, that North First street is fifty feet wide, that North Second street and Third street are each forty feet wide. That Rose and Montana avenues and Q.P.D. and D. streets are each eighty feet wide and that each of the alleys are eighteen feet wide.
