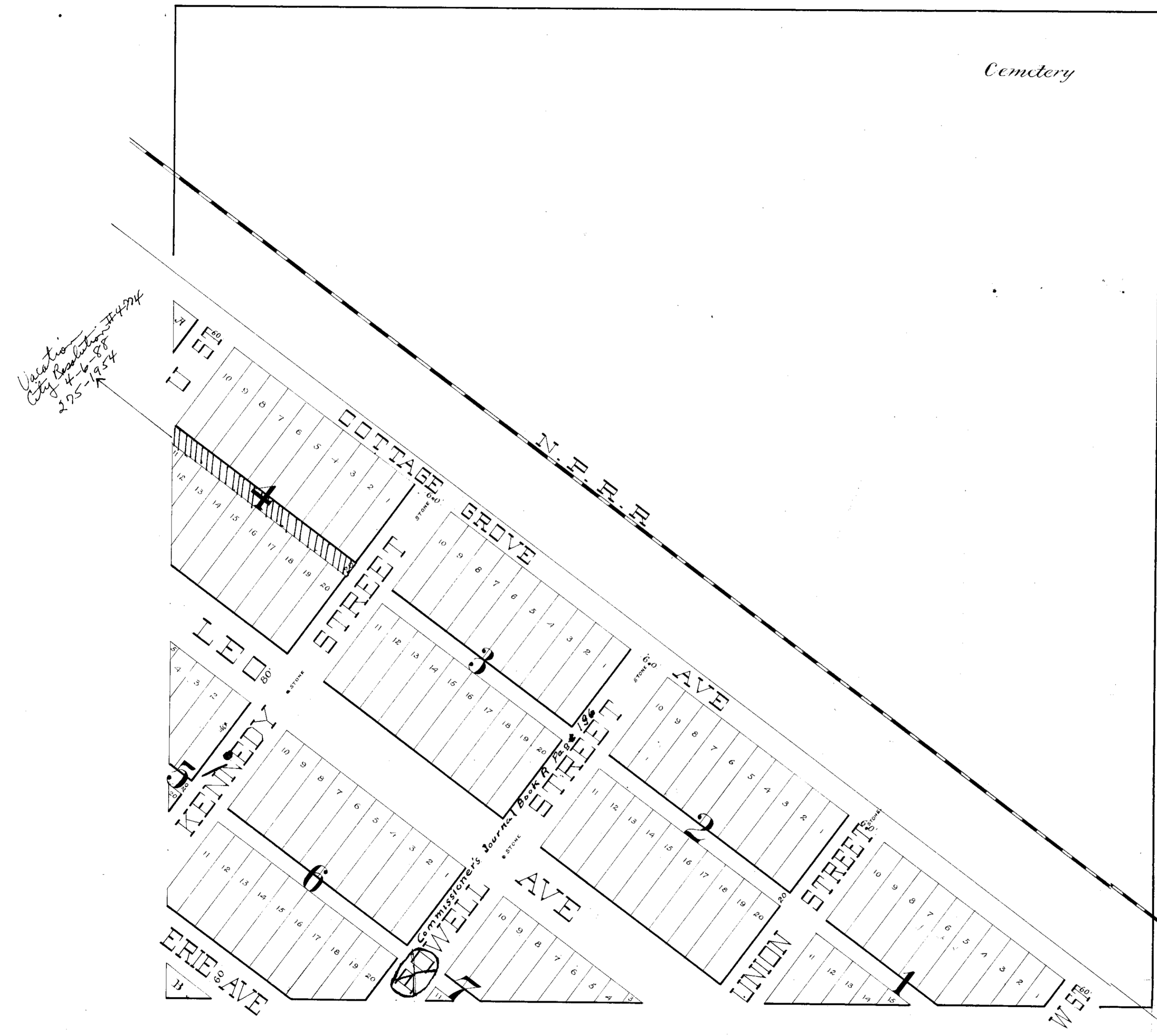


WEST MISSOULA

Know ye that I Joseph Solomon being the owner in fee of all the land embraced in West Missoula and being that portion of the Northeast Quarter of the North east Quarter of Section Seventeen lying South of the N.P.R.R. Township No 13 North of Range Nineteen West, have caused the same to be surveyed and platted as shown in annexed plat and intend to file the same as a public record to be known and designated as West Missoula. That the streets and alleys as shown in said plat are hereby declared public and dedicated to public use.

Lincoln O. Kennedy being duly sworn on oath says, I am a Civil engineer that during the month of November 1889 I executed a survey of the blocks, lots, streets and alleys represented by this plat and called West Missoula, that said West Missoula was surveyed and laid out according to this plat, that Leo Avenue is eighty feet wide, that Erie Avenue is sixty feet wide, that Cottage Grove Avenue is fifty feet wide, that U. St. Kennedy street, Powell street, Union street and Lincoln street are each sixty feet wide, that the alleys in said West Missoula are twenty feet wide.
