Shelling, being the owner in fee of all the land embraced in the Bennett Addition and the north part of the block that by a certain party, some time ago, have caused the same to be surveyed and platted as shown in said plat and intend to file the same as a public road & to have and to grant as Bennett Addition and to declare the streets and alleys therein as shown by said plat to be public and they are hereby dedicated to the public.

Know all men that on the 3rd day of January 1890, I, Joseph M. Shelling, do hereby depose and say that I am a civil engineer and that in the month of January 1890, I executed a survey of the lots, blocks, streets, and alleys represented by this plat and called Bennett Addition, that said Bennett Addition was surveyed and laid out according to this plat, the streets are all eighty feet wide, the alleys are all twenty feet wide and the blocks are all two hundred and eighty feet by four hundred feet.
