

RESOLUTION NO. 2021-114

**EXTENSION OF A SCHOOL ZONE AND SCHOOL ZONE SPEED LIMIT AT CLINTON
ELEMENTARY SCHOOL EAST MULLAN ROAD, CLINTON, MT**

WHEREAS, the Board of County Commissioners is given authority to control and manage county roads within the county by §7-14-2101 MCA; and

WHEREAS, the Board of County Commissioners is given authority to place traffic control devices on roads under their jurisdiction to regulate traffic by §61-8-206 MCA; and

WHEREAS, the Board of County Commissioners is given authority to decrease the speed limit in an area near a school and requires that signs be erected designating the school zone speed limit by §61-8-310 MCA; and

WHEREAS, the Board of County Commissioners established the existing school zone by Resolution #2014-095 on August 13th, 2014; and

WHEREAS, the Clinton School District has expanded their campus to include a non-contiguous parcel located at 20359 East Mullan Road, which includes a building that is used for daily school activities; and

WHEREAS, Public Works Department staff consulted with the Clinton School District pursuant to §61-8-310(7) MCA to extend the school zone; and

WHEREAS, speed limits cannot be enforced without the installation of proper signage pursuant to §61-8-704 MCA; and

WHEREAS, §61-8-726 MCA doubles the penalty for violating a speed limit in a school zone which has been set pursuant to §61-8-310 MCA.

NOW, THEREFORE, BE IT RESOLVED that the existing school zone be extended on East Mullan Road as shown in Exhibit 1.

BE IT FURTHER RESOLVED that a 25 Mile Per Hour school zone speed limit be established on East Mullan Road at the Clinton Elementary School weekdays during the school year from 7:00 AM to 9:00 AM and from 3:00 PM to 5:00 PM.

BE IT FURTHER RESOLVED that the County Public Works Director place appropriate signs on East Mullan Road indicating the school zone and school zone speed limit.
