

**REGULATING OVERNIGHT PARKING IN SOMMERS STREET & MICHIGAN AVENUE
ADJACENT TO SOMMERS STREET VILLAGE
SECTION 24, TOWNSHIP 13 NORTH, RANGE 19 WEST**

WHEREAS, vehicles parked on Sommers Street and Michigan Avenue adjacent to storage units have created a public nuisance for local property owners; and

WHEREAS, children are using this right-of-way to access the local area schools and parks; and

WHEREAS, Mont. Code Ann. § 45-8-111(1)(c), specifies that rendering dangerous for passage a public right-of-way constitutes a public nuisance; and,

WHEREAS, the Missoula Board of County Commissioners may do whatever is necessary for the best interest of a County road as provided in Mont. Code Ann. § 7-14-2102; and,

WHEREAS, the Board of County Commissioners is authorized by Mont. Code Ann. § 7-14-2106, to adopt regulations governing parking on County roads; and

WHEREAS, Mont. Code Ann. § 61-8-705, authorizes the removal of illegally parked vehicles in conjunction with Mont. Code Ann. §§ 61-8-353 thru 61-8-355, and

NOW, THEREFORE, BE IT RESOLVED that parking adjacent to Sommers Street Village, in Section 24, Township 13 North, Range 19 West, is hereby prohibited between 10 p.m. and 6 a.m. along the southwesterly side of Sommers Street and the northwesterly side of Michigan Avenue as shown on Exhibit A.

BE IT FURTHER RESOLVED that the County Public Works Director provide appropriate signs indicating the restrictions and that vehicles may be towed.

BE IT FURTHER RESOLVED that Missoula County Sheriff is hereby requested to take such action as is required to assure compliance with the parking regulations in the affected right of way including having vehicles towed if necessary.


