



RESOLUTION NO. 2008- 050

REGULATING PARKING, PUBLIC USE AND PUBLIC BEHAVIOR IN THE RODEO RANCHETTES SUBDIVISION

WHEREAS, vehicles parked on the travel way of Oral Zumwalt Way have in the past created a hazard; and

WHEREAS, certain persons using Lot 13 (a County-owned lot) of the Rodeo Ranchettes Subdivision, Phase I as a public access to the Bitterroot River have in the past created a public nuisance for local property owners; and

WHEREAS, the public has the right to use said lot as a public river access; and

WHEREAS, public rights-of-way may be used for temporary parking; and

WHEREAS, the Board of County Commissioners is authorized by §61-21-101, M.C.A., to adopt regulations governing parking on County roads; and

WHEREAS, §61-8-705, M.C.A., authorizes the removal of illegally parked vehicles in conjunction with §61-8-353 through §61-8-355, M.C.A; and

WHEREAS, §45-8-111, M.C.A., specifies that rendering dangerous for passage a public right-of-way constitutes a public nuisance.

NOW, THEREFORE, BE IT RESOLVED that parking, public use and public behavior on Lot 13 of Rodeo Ranchettes Phase I, Oral Zumwalt Way and Inclination Way is hereby regulated as shown on Exhibits 1 and 2.

BE IT FURTHER RESOLVED that the County Public Works Director place appropriate signs on Lot 13 of Rodeo Ranchettes Phase I, Oral Zumwalt Way and Inclination Way indicating the regulations.




