RESOLUTION NO. 2023 - 045 REGULATING PARKING ON HIGHWAY 200 AND SPEEDWAY AVENUE SECTION 13, TOWNSHIP 13 NORTH, RANGE 19 WEST

WHEREAS, vehicles parked on Highway 200 and Speedway Avenue around Sha-Ron Fishing Access Site have created a public nuisance for some local property owners and the traveling public; and

WHEREAS, Missoula County, Montana Fish Wildlife and Parks, and Montana Department of Transportation have collaborated to construct a parking lot along Highway 200 to allow for parking near Sha-Ron Fishing Access Site; and

WHEREAS, Mont. Code Ann. §45-8-111 specifies that rendering dangerous for passage a public right-of-way constitutes a public nuisance; and

WHEREAS, the Board of County Commissioners is authorized by Mont. Code Ann. § 7-14-2106 to establish by resolution parking regulations for the purpose of regulating parking of vehicles in unincorporated areas of Missoula County; and

WHEREAS, Mont. Code Ann. §61-12-101(1) authorizes local authorities to regulate standing or parking vehicles on streets and highways within the jurisdiction of the local authority; and

WHEREAS, Mont. Code Ann. § 61-8-705, authorizes the removal of illegally parked vehicles in conjunction with Mont. Code Ann. §§ 61-8-353 thru 61-8-355, and

NOW, THEREFORE, BE IT RESOLVED that parking on Highway 200 and Speedway Avenue in Section 13, Township 13 North, Range 19 West, is hereby prohibited as shown on Exhibit A.

BE IT FURTHER RESOLVED that the Montana Department of Transportation provide appropriate signs on Highway 200 indicating the restrictions and that vehicles may be towed.

BE IT FURTHER RESOLVED that the Missoula County Director of Public Works provide appropriate signs on Speedway Avenue indicating the restrictions and that vehicles may be towed.

BE IT FURTHER RESOLVED that Missoula County Sheriff is hereby requested to take such action as is required to assure compliance with the parking regulations in the affected right of way including having vehicles towed if necessary.


